



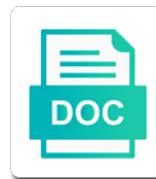
Florida Late Term Abortion Law

In 2019, the Florida Legislature passed a law that bans late-term abortions. The law is known as the "Florida Late Term Abortion Law". It is a controversial issue that has sparked debate and protests across the state.
